Significance of public purchases in increase of state budget revenues in our country and mechanisms of its improvement

The decision of the President of the Republic of Uzbekistan on measures to implement the Law of the Republic of Uzbekistan "On State Procurement" was

adopted on September 27, 2018 with PQ No.-3953². In accordance with this Decision, in order to effectively implement the Law of the Republic of Uzbekistan "On State Procurement", the following will be posted on the private information portal for Public purchases www.xarid.uz:

According to the implementation of this Decision, changes have been made to the electronic system for Public purchases and to the private information portal of "UzRTSB" AK www.xarid.uz.

Control over Public purchases in budget organizations is carried out by the Accounts Chamber of the Republic of Uzbekistan, the General Prosecutor's Office of the Republic of Uzbekistan, the Anti-Corruption Agency, the Ministry of Economy and Finance, and the Anti-Monopoly Committee. The Accounts Chamber of the Republic of Uzbekistan is a budget organization and one of the bodies that exercises control over state procurement. In the course of its activities, the Accounts Chamber carries out state procurement at the expense of budget funds and is registered by the Ministry of Justice on May 7, 2021 with No. Financial information, as specified in the regulation "On the procedure for posting information", has been published in detail on the "Open Budget" page³. It is known that the period of the electronic auction for Public purchases has been reduced from 10 days to 5 days, and the period of placing tender announcements on the portal has been reduced from 30 days to 10 days. Also, the list of procurement types and products (services, works) for Public purchases, which are not considered as non-enhanced. To get a document, you can visit the official website www.uzex.uz or the official website of the state procurement period portal www.xarid.uz. Regulatory documents regulate the procurement of products, works, and services for the provision of state documents. According to the laws related to the purchase of products, works and services, the completeness of the intended actions, starting from the determination of the salable status, is provided as the execution of limited obligations of the state and city authorities in the protected period.

The Public purchases system is an important mechanism for effective management of state budget revenues and expenditures. It helps the development of various spheres of economic activity through the conclusion of contracts on goods, services and works by the state. Public purchases in the Republic of Uzbekistan is mainly aimed at implementing infrastructure projects, providing social services and meeting state needs. These purchases not only stimulate economic activity, but also serve to increase the revenues of the state budget by creating new jobs and supporting domestic production. Correct and effective organization of Public purchases is important for filling the budget and using it effectively. For example, through the

Thus, every stage of Public purchases, including tenders, conclusion and execution of contracts, is monitored by the public and responsible organizations. This helps to make Public purchases effective and fair, and to create equal competitive conditions in all areas. In addition, systems aimed at strengthening competition and providing high-quality products and services are being introduced in the Public purchases system. Strengthening competition also helps to reduce the prices of purchases and improve the quality of services. These processes serve to effectively replenish the state budget and maintain the economic stability of the state.

Public purchases, with its high volume, has a strong impact on economic development. The government itself stimulates several economic sectors with the goods and services it purchases. For example, construction projects and infrastructure facilities implemented by the state (roads, bridges, electric power systems) create an important foundation for the country's economy. Summary

In general, it would be appropriate for Uzbekistan to use this experience and use Public purchases as a means of economic development and increasing budget revenues.
